2016/2017 was, despite the challenges being faced by the Newfoundland and Labrador economy, a positive year for our YMCA.

The Ches Penney Family YMCA in St. John's operated for a fifth full year, the new Marystown YMCA operated for a first full year, and in Children's Services we again scored 100% in our preschool child care curriculum assessment. We opened new school age child care centres, we received funding for new employment and enterprise programs, and we moved closer to final agreements for a new YMCA in partnership with the Town of Happy Valley-Goose Bay in Labrador. Near the end of the year, we entered into a management agreement with Common Ground Coworking Inc.

We invested in a new technology system set to launch in 2018 to help ensure we are managing carefully and connecting with people participating in our programs.

In all areas, the need for financial assistance increased; this will drive the need for the YMCA to expand annual fundraising efforts to support accessibility to all.

The Board of Directors approved a new strategic plan to guide the development of the YMCA for the next 10 years. Plans are based on the YMCA being sustainable, relevant, and having impact in all of our communities across the province.

The YMCA engages thousands of people in needed programs in Newfoundland and Labrador. We thank our members, families, donors, volunteers, staff, partners, and stakeholders for their commitment to the YMCA and our communities.




