Memberships are eligible for cancellation once the initial three-month commitment period has passed. Only the payer can cancel a membership. To cancel, you must provide a written request to cancel a minimum of 15 days before your scheduled payment date and pay a \$25 cancellation fee. This fee is not applicable to financially assisted members or child members aged 0-11. Verbal requests to cancel are not accepted. A written request to cancel can either be done in person by visiting your membership location to sign the cancellation portion of your original Membership Registration Form; or by completing and submitting the following online form found on our website at [ymcanl.com](http://ymcanl.com) labelled as **Cancel Membership Form**. When processed, the payer will receive a cancellation confirmation via the email address listed on file. Facility access remains active until the last day of your payment period. If membership is re-activated within six months of cancellation, the Joiner Fee will be waived.
