## Membership Agreement Form

Please check with a physician prior to beginning an exercise program.

### **Continuous Membership**

YMCA memberships automatically renew. Members will be charged monthly in accordance with the member's pre-authorized payment method. Fees are based on enrollment, not usage, and are non-transferable and non-refundable.

### Joiner Fee

A one-time, non-refundable Joiner Fee of \$75.00 +HST is applied to all adult, fitness buddy, and family memberships. Memberships that are reactivated within six months of cancellation will be exempt from the Joiner Fee.

### **Cancellation Policy**

To cancel, the payer of the membership must provide a written/email request a minimum of 15 days before the scheduled payment date to cancel. If not within this minimum notice period, the normal scheduled payment will occur, and the membership will remain active for that paid period. A written request to cancel can either be done in person by visiting your membership location; or by completing and submitting the following online form found on our website at <u>ymcanl.com</u> labelled as <u>Cancel Membership Form</u>. Verbal requests to cancel are not accepted. When processed, the payer will receive a cancellation confirmation via the email address listed on file. Facility access remains active until the last day of your payment period. Cancellation fees are included in your Joiner Fee. If there is a balance owing on your account, this must be paid before you can cancel.

### **Refunds after Cancellation of Membership**

Membership fees incorrectly charged to you by the YMCA following the cancellation of your membership in accordance with the YMCA's Cancellation Policy will be fully refunded. <u>In such circumstances, please note that refunds will only be issued up to a period of six (6) months following the effective date of cancellation</u>. You understand that it is your responsibility to confirm with your financial institution/credit card company that YMCA membership fees are no longer being deducted/charged following the cancellation of your membership.

### **Payment Information**

• Pre-authorized payments can be applied to Visa, Master Card, American Express or personal bank accounts (a void cheque or pre-authorized payment form from your bank is required).

- Membership fees are due upon registration, then are charged monthly to your preauthorized payment method. Charges can take several days to appear on your account.
- The YMCA is not responsible for bank fees incurred due to <u>Non-Sufficient Funds</u> (NSFs). Balances owing must be paid in full to access the facility or to cancel.
- The YMCA applies minimal fee increases annually. Notification will be provided 15 days prior to the scheduled increase, and failure to cancel your membership shall be deemed acceptance of the fee increase.
- It is the payer's responsibility to update changes to payment and contact information (e.g., credit card expiration dates, mailing address), and the YMCA shall not be liable for any losses resulting from a payer's failure to update their information.
- Payments are non-refundable, and refunds or credits are not provided for non-usage.

## **Membership Declaration**

## **Conditions and Agreements**

- The <u>Assumption of Risk and Waiver of Liability</u> must be completed for all members. You can complete the waiver through the <u>Online Portal</u> or through our website at <u>ymcanl.com/waivers/.</u>
- Membership barcodes are required to be scanned upon each visit
- Children under the age of 12 years must be accompanied by an adult (19+) while in the facility, unless signed into a staff supervised program. The exception is Child Minding where adults must remain in the facility.
- The YMCA reserves the right to modify hours of operation, programming, and to withdraw all or any part of our physical facilities for maintenance or events. The YMCA also reserves the right to suspend or terminate membership privileges, without refund, for inappropriate behaviour or failure to comply with our YMCA Etiquette Statement: *"The YMCA is a shared experience for everyone to enjoy. Each of us can make it better for all by being considerate to others. YMCA members, participants, clients, visitors, staff and volunteers all pledge to treat one another with respect and dignity."*
