

Child Care Program Priority Factors

Considerations

- All families interested in enrolling their child(ren) in a YMCA Child Care Program or Service must complete a waitlist application either through the YMCA waitlist application service or the Early Learning Gateway (ELG)
- Families must have accepted and been enrolled in a child care space prior to July 1, 2025.
- All families must notify the registrar by April 1 prior to the commencement of the academic year what school location your child will be attending
- All families must complete a new registration package for their child to match their new program involvement.

Early Learning Child Care/ CPFY

-Is your child currently enrolled in the YMCA Child Care Center/ CPFY?
-Has your child been enrolled in a YMCA Child Care Program or Service prior to July 1, 2025?
-Does your currently enrolled child have a sibling that is indicated on the YMCA application service or ELG?



-If these apply to you, the indicated sibling will be noted as a priority for a space once available.
- If your child holds enrollment in a YMCA Child Care Service prior to the aforementioned date and is transitioning to school the following September, your child will receive priority for a space in our School Aged Child Care Program. The deadline for informing the registrar of your requested location will be **April 1** prior to the upcoming school year.

Brookfield District Child Care Center

-Are you employed with NL Health Services or recognized as a registered physician in the province?
-Is your child currently enrolled in the YMCA Brookfield District Child Care Center?
-Does your currently enrolled child have a sibling that is indicated on the YMCA application service or ELG?



-If the health care employment criteria applies to you, you will receive priority for a child care space.
-If there is a waitlisted sibling for the program, they will receive priority for a space at **Brookfield District Child Care Center only**.

Central Labrador YMCA Child Care Center/ CLY

-Are you currently employed with NL Health Services or recognized as a registered physician in the province?
-Is your child currently enrolled in the Central Labrador YMCA Child Care Center/ CLY?
-Does your currently enrolled child have a sibling that is indicated on the YMCA application service or ELG?



-If the health care employment criteria applies to you, you will receive priority for a child care space.
-If there is a waitlisted sibling for the program, they will receive priority for a space at the **Central Labrador YMCA Child Care Center only.**

School Aged Child Care

-Is your child currently enrolled in the YMCA Child Care Center/ CPFY or the School Aged Child Care Program?
-Has your child been enrolled in a YMCA Child Care Program or Service prior to July 1, 2025?
-Does your currently enrolled child have a sibling that is indicated on the YMCA application service or ELG?



-If these apply to you, the indicated sibling will be noted as a priority for a space once available for **the same SACC service location** where your child is currently enrolled.
-If a sibling is waitlisted for the ELCC program, the sibling will be noted as a priority for upcoming space availability within the **YMCA Child Care Center/ CPFY only.**

Pre-Kindergarten Program

-Does your child have a sibling currently enrolled in the Pre-K Program?
-Does your child have a sibling who is indicated on the ELG or YMCA waitlist application service that would be age eligible to attend Pre-K in the same program year?



-If these apply to you, your child will receive priority for a space in the **same program location** where your original child is enrolled.
